### What is WIC?

- Official name: Special Supplemental Nutrition Program for Women, Infants, and Children.
- WIC is a preventative nutrition program.
- WIC provides:
  - Nutrition education and counseling.
  - Breastfeeding education and support.
  - Supplemental, nutritious foods.
  - Referral services.



### Who Does WIC Serve?

- Women.
  - Who are pregnant.
  - Who are postpartum up to 6 months after birth.
  - Who are breastfeeding an infant up to 12 months of age.
  - Who have an infant under 6 months of age.
- Infants.
  - From birth to 12 months of age.
- Children.
  - From 1 to 5 years of age.




### WIC

- There are 75 local WIC projects in Ohio with clinics in all 88 counties.
- Federal Fiscal Year 2024 average monthly participation in Ohio:
  - 178,839 total participants.
    - 41,477 women.
    - 43,515 infants.
    - 93,847 children.
- February 2025 average monthly participation in Ohio:
  - 177,399 total participants.
    - 40,829 women.
    - 42,960 infants.
    - 93,610 children.
- Funding is based on caseload.

# Eligibility

- 1. Identification.
  - Provide personal identifying info to the local WIC clinic.
- 2. Categorical.
  - Pregnant, postpartum, or breastfeeding women; infant; child (up to age 5).
- 3. Residential.
  - Lives in the state of Ohio.
- 4. Medical/Nutritional Risk.
  - Determined by local WIC health professional.

\*Eligibility is based on WIC Program Federal Requirements.



# **Eligibility (Continued)**

- 5. Physical Presence.
  - Applicant/participant must be present at the local WIC clinic for the appointment.
- 6. Income.
  - 185% of the Federal Poverty Guidelines.
    - Ex. A family of four grossing up to \$57,720 annually is income-eligible.
  - Adjunctive eligibility (Medicaid, SNAP, TANF).



### **Kinship Care**

- Adjunctive Eligibility.
  - Child receiving SNAP, Medicaid, and/or TANF is automatically eligible for WIC.
- If not enrolled in SNAP, Medicaid, and/or TANF, income is determined based on the household size where the child is living.
- Contact the local WIC clinic for guidance on who can bring the child and the required paperwork.



### **WIC Food Benefits**

- Milk.
- Yogurt.
- Cheese.
- Eggs.
- Breakfast cereals.
- Juice.
- Canned fish.

- Fruits and vegetables.
- Peanut butter.
- Canned and dry beans.
- Whole grains.
- Infant cereal.
- Infant formula.
- Commercially prepared infant fruits/vegetables and meats.



### **WIC Food Benefits**

### Cash Value Benefits for fruits & vegetables.

- Fresh, frozen, or canned fruits and vegetables.
- Dollar amount varies for participant category.
- Total amount dependent of federal budget.

### **Current values:**

- \$26/month for children.
- \$47/month for postpartum, and minimally breastfeeding women.
- \$52/ month for pregnant and exclusively breastfeeding women.
- \$78/ month for women exclusively breastfeeding multiples.



### **Redemption of Benefits**

- Benefits issued to the WIC Nutrition Card (WNC).
- Specific to participant's nutritional needs.
- WNCs can be used at more than 1,100 authorized vendor locations.
- Can only purchase items/quantities that have been issued to WNC.
- Items contained in a state-approved UPC database.

• Free downloadable app designed to make WIC shopping easier.







# **Breastfeeding Education and Support**

- Integrated into the education of all pregnant and postpartum WIC participants.
- Support is provided by local staff:
  - International Board-Certified Lactation Consultant (IBCLC).
  - Certified Lactation Counselor (CLC) or similar.
  - Breastfeeding Peers.

#### FUNDED BY THE OHIO DEPARTMENT OF HEALTH

Goals:

- To provide nutritious, unprepared, locally grown fresh fruits, vegetables, and herbs from farmers' markets and roadside stands to income-eligible, nutritionally at-risk women and children who are participating in the WIC Program.
- To expand the awareness, use of, and sales at farmers' markets.
- To develop and or aid in the development of new and additional farmers' markets and roadside stands.



### Funding:

- USDA.
  - 100% Food.
  - 70% Administrative.
- State.
  - 30% Administrative.
    - Ohio Department of Aging Senior Farmers' Market Nutrition Program.
    - WIC Vendor Recovery Funds.



- \$30 per participant (six \$5 coupons).
  - Redeemable at participating farmers' markets and roadside stands.
- Coupons redeemable from June 1 Oct. 31.
- Seventy counties participating.
- For FFY24, 108,049 FMNP coupons were redeemed resulting in over \$540,000 of fruits and vegetables to Ohio families and income to Ohio farmers.
- Local WIC projects are the key to the program's success!



Farmer and Market Master Contracting:

- ODH contracts with Market Masters and individual farmers for up to three years at a time.
- Local WIC staff provide training and information to farmers and Market Masters.
- Days and hours of markets are shared with local WIC staff and available to participants in the WIC Shopper app.



- Farmers accept coupons from the WIC participants for fresh fruits, vegetables, and herbs.
- Market Masters collects redeemed WIC coupons from farmers and submit for payment for state WIC and are responsible for reimbursing farmers.
- Farmers contracted individually submit coupons for payment for state WIC.
